The information on this page is intended for those residents who were unable to attend the Parish Council presentation which took place on May 10th 2024.

This survey is being carried out by the Parish Council as a follow-up to the results of the traffic report completed by the consultants Moss Naylor Young earlier this year.

The Moss Naylor Young report was based on a thorough and detailed analysis of traffic flows through the village based on both Automated Traffic Counters and Video Surveillance.

The report suggested 4 main areas that could be addressed by the Parish Council: these are

- Speed in vicinity of Barton Road / High Street junction
- Congestion (and pedestrian safety) in Village centre at peak times to include parking near shop & Castle Street
- Congestion near school at collection / drop off times
- Visibility and safety at the Queen Street / Common Lane Junction

The Parish Council will use the information you provide in this survey to decide what the most appropriate strategies might be to address these issues, or at least some of them.

We emphasise that the ideas on this questionnaire are those suggested by Moss Naylor Young in their report, not by the Parish Council

It is important to bear in mind that it is the Parish Council that will be funding any works undertaken, so the budget may be limited. A rough guide to possible costs is given on the back of this form.





Yellow area = box junction Red arrows = traffic priority direction Red blocks = buildouts Red line = widened pavement.




